





# **Country's First Namo Bharat** Rapidex Train In Sahibabad

on'ble Prime Minister Shri Narendra Modi inaugurated a section of 160 km per hour **Namo** Bharat Rapidex train in Sahibabad. Uttar Pradesh. He also flagged off the Namo Bharat Rapidex train connecting Sahibabad to Duhai Depot, marking the launch of the Regional Rapid Transit System (RRTS) in India. Shri Naresh Tomer, General Secretary of Federation of Indian Small Scale Battery Associations, was also among those who welcomed the Prime Minister.

The Prime Minister said in his address that today is a historic moment for the entire country. Today India's first rapid rail service, Namo Bharat Train is being dedicated to the countrymen. of progress and development in every field." He also mentioned the success of Chandrayaan 3 which made India the center of attraction for the entire world and the successful organization of G20. He mentioned the record performance of winning more than 100 medals in the Asian Games, the introduction and expansion of 5G in India and the record number of digital transactions. Sh. Modi also mentioned the Made in India vaccines which proved to be life-saving for crores of people across the world. Referring to India's rise in manufacturing sector, he also discussed about the eagerness of multinational companies to set up manufacturing units in India for mobile phones, TVs, laptops and computers. He also mentioned defense manufacturing, including fighter aircraft and the aircraft carrier INS Vikrant. "Namo Bharat train is also made in India," Shri Modi said. He said the screen doors installed on the platforms are also made in India.

Indian Railways is close to the target of 100 percent electrification. He listed initiatives like modern trains like Namo Bharat and Vande Bharat and modernizing railway stations under Amrit Bharat Railway Station Scheme. He said, "This Triveni of Amrit Bharat, Vande Bharat and Namo Bharat will become a symbol of modernization of Indian Railways by the end of this decade."

# How to double battery life by reducing DOD



Shri Gaurav Deep Sharma

s we all know, the process taking place in lead acid battery is by oxidation of oxide in which we preserve the chemical energy in the form of electric energy

inside the battery and this process continues until all the oxide is oxidized. or the battery does not become completely sulphated. So if I understand this from another aspect, if the speed of oxidation is reduced then the life of the battery will increase. In other words, if we get 3 years of battery life at 80% DOD, then if its DOD is increased to 50%, then that life can increase to 6 years as is the case in big power banks. Generally we see that a battery lasts for 3 to 4 years on a 1/2 kilowatt inverter. If the same battery is installed on a 1 kilo watt inverter, it will last for 5 to 7 years only because of its low DOD and slow oxidation. Traders will understand this very well that only one lot Some batteries last less time while some batteries last longer than required, so this result is different only because of its oxidation speed or DOD.

I hope I have succeeded in explaining my point. See you soon with another topic, till then Jai Hind Jai Bharat.

Kailash Gehlot wrote in a post on his 'X' (old name Twitter) that the Delhi Cabinet under the leadership of Chief Minister Arvind Kejriwal has extended the existing Delhi Electric Vehicle Policy till December 31 or the notification of Delhi EV Policy 2.0, whichever is earlier., has been approved to increase.

# Subsidy benefits will also continue

Delhi Transport Minister Kailash Gehlot said that all incentives including subsidies will continue under the existing policy. Delhi EV

Policy 2.0 is in the final stages and will be notified soon after necessary approvals. Delhi Electric Vehicle Policy 2020 expired on August 8 this year. The policy, notified in August 2020 in Delhi, aims to increase the share of EVs to 25 per cent by 2024.

# Delhi government serious about EV

The Delhi government is serious from the beginning about introducing electric vehicles in the country's capital. Its main objective is to reduce the pollution level in Delhi. The effect of this stance of the Delhi government is that the national capital has the highest number of electric vehicles in the country. Delhi Transport Corporation also has more than 800 electric vehicles in its fleet.

# Highest number of EV vehicles registered in Delhi

Registration of electric vehicles has increased two and a half times in Delhi in 2022 compared to 2021. A total of 25,817 EV vehicles were registered in the year 2021, while 61,945 electric vehicles were registered in the year 2022. Of the total electric vehicles registered in the country, 10 percent are registered in Delhi only.

# Lithium batteries will be Made in UP

There will be an investment of Rs. 10 thousand crores, it will be a game changer for the industrial picture of the state.

P has invited big industrial groups to make lithium batteries. It is expected that in the first phase there will be an investment of at least Rs 10 thousand crore in the lithium battery sector.

Despite the huge demand for EVs in the country, 100 percent of lithium batteries are being imported. 80 percent of the batteries are being imported from China. Apart from this, there are also imports from Chile and Australia. Last vear, batteries worth about Rs 14 thousand crore were imported. Recently, Tata Group has announced to set up a lithium battery plant in Gujarat with an investment of about \$ 1.60 billion. Now UP has invited big groups regarding batteries.

It is noteworthy that Hinduja Group has recently signed an MoU with the state government to set up an electric vehicle manufacturing plant. Under this, the group will set up a commercial EV plant in Lucknow or Prayagraj. For the first time, the world's fourth largest commercial vehicle company has signed an agreement to set up a plant outside South India. With this, a new sector has also entered UP.

The focus of the department is not only on EV vehicle plants but also on creating a manufacturing hub for lithium batteries, the 'lifeline' of EV wehicles. The department believes that in the first phase there will be an



investment of at least Rs 10 thousand crore in the lithium battery sector. According to departmental sources, just as Mahindra changed the picture of Tamil Nadu and Tata changed the picture of Pune, similarly the cluster of lithium batteries and EV vehicles will change the industrial picture of UP.

#### **Highest sales of EV** vehicles in UP

Sales of EV vehicles in the country have increased 48 times in five vears. UP tops the country in its sales. So far this year, 4.35 lakh EVs have been sold here. The network of expressways, national highways and roads has expanded rapidly here. The 12 thousand km National Highway is passing through here. This is the reason why the sale of EV vehicles in the state is likely to cross 12 lakh annually in the next three years.

It contains vital details such as biometric information, fingerprints, iris scan image and facial images. This detail is completely confidential. No one can use them without your permission. Therefore, it is essential to keep this detail safe. Even the slightest mistake can lead to fraudsters misusing your biometric details.

#### What will happen if biometric is locked?

Provides the facility of authorization lock and unlock to prevent misuse of Aadhaar card. Any person can lock his biometric details. This makes it completely safe. Once the details are locked no one will be able to use it. If Aadhaar details are required for any work then it can be temporarily unlocked and used. If the Aadhaar card is lost then the first thing to do is to lock the details.

#### Take help via sms

First of all write GETOTP and give space and write the last four or eight digits of the Aadhaar number and send it to number 1947. After this you will get six digit OTP. Then to lock, write LOCK UID and give space and write the last four or eight digits of Aadhaar, then give space again and write OTP. Send it to 1947.

To unlock, write UNLOCK UID, give space and write the last four or eight digits of the Aadhaar number. After this give space again and enter OTP. Aadhaar card with this Will be unlocked:

ndia is entering its lithium-ion battery revolution in full swing, with its ambitious targets of achieving 40% renewable energy transition and EV penetration by 2030. EV sales are witnessing a steady growth due to supportive policies, incentives and greater awareness than ever before about environmental issues.

The increase in demand for batteries raises concerns about the disposal and environmental impact of used batteries, as well as the sourcing of materials for battery manufacturing.

Lithium-ion batteries are ubiquitous in modern life. They power everything from our smartphones to electric vehicles (EVs) and renewable energy storage systems.

Most of the materials used to produce lithium-ion batteries are largely unavailable in India, and most other countries are also heavily dependent on China for lithium as well as various other components of the battery and EV supply chain. .

With the help of India's ambitious Faster Adoption and Manufacturing of (Hybrid and) Electric Vehicles in India (FAME) schemes, India has been able to significantly increase its EV penetration in the last two years. According to the latest data from MoRTH, there are 13.34 lakh registered EVs in India.

The absence of a unified regulatory framework for battery recycling was addressed with the announcement of battery waste management rules in August 2022, which articulate the role of ecosystem stakeholders, the scope of partnerships, and progressive targets for recycling as well as use. Defines formally.

According to a report by NITI Aayog and Green Growth Equity Fund Technical Cooperation Facility, the collective capacity of lithium-ion . batteries in India is estimated to reach about 600 GWh by 2030. By 2030, it is estimated that approximately 128 GWh of these batteries will be recycled, ' with approximately 59 GWh originating exclusively from the EV sector.







# Metal battery, not lithium, can also be an option

y now you must have heard about lithium batteries in electric vehicles. In such a situation, if we say that metal air batteries will soon be seen in EVs instead of lithium, would you believe it? Actually, lithium battery is the most expensive unit in electric vehicles. Lithium batteries are imported in large quantities in India. # China may ban the export of graphite

hina is about to ban the export of graphite. China's Ministry of Commerce and General Administration of Customs has given this information. China produces the most graphite in the world. China's share in the world's graphite production is 65 percent. Last year, China produced the most graphite in the world. In such a

# **Solar Panels Will Have Star Rating Label**

This program is voluntary in the initial two years and After that it will be made mandatory

he government has come up with a standard and star labeling program for solar panels. This program will be organized on October 20, 2023 in New Delhi by the Union Minister of Power and New and Renewable Energy, Shri R.K. Started by Singh. This program will help the citizens of the country to purchase suitable PV modules i.e. solar panels developed under the star labeling scheme prepared by the Bureau of Energy Efficiency (BEE). This scheme is for the period from January 1, 2024 to December 31, 2025. For this period, there will also be no labeling fee.

This will enable customers to get better information about the costs and energy savings they will incur by using solar panels. The effort also contributes to the government's larger goal of increasing the share of renewable energy and reducing emissions intensity of GDP by 45 percent by 2030.

Right now the consumer has no option but to follow the instructions of the installers. With the advent of star labeling program, citizens can know which solar panel is more or less efficient.


Shri Singh said that the standards and labeling program is in public interest and he also said that our program for star labeling is world leading and will result in reduction of carbon dioxide emissions by 03 crore tonnes per year. It is essential for the survival of this planet

The Minister of Power and New & Renewable Energy called upon all manufacturers of solar panels to come and get themselves listed in the Star Labeling Programme.

Shri Singh said that this program is voluntary in the initial two years and after that it will be made mandatory. We have empowered consumers to choose better options. This program is





voluntary for the initial two years and then after one year we will review it and if we feel that the industry is not coming forward for labeling then we will make it mandatory because it is a matter of public interest. I urge all module manufacturers to include themselves in the panel.

The government will bring a policy after 2 years, under which PV cells will also be manufactured in India and will not be imported from anywhere else. Over the next two years, we will focus on making the wafers in India so that our solar panels are 100 per cent made in India and high quality solar panels, where first the cells and then the wafers for these will also be made in India.

# This program will help citizens to make the right choice

Union Energy Secretary Shri Pankaj Aggarwal said that the star labeling program will enable the retail consumer to make the right choice by enabling them to better differentiate between different models of solar panels which currently look similar. "The Star Labeling program will bring product differentiation in a market where products have been completely commoditized till now. At present, the

citizen does not know which product is good. "This program will help citizens make the right choice."

Shri Abhay Bakre, Director General, Bureau of Energy Efficiency (BEE) said that the growth of solar PV modules has been tremendous and will grow further. From now till 2030, we hope to add at least 200 GW of solar panels, both ground-mounted and solar roof tops, as we now have an ambitious plan to tackle climate change.

Shri Abhay Bakre said that the program is based on effective efficiency and is expected to increase solar PV module efficiency by 2 percent from its current levels. Additionally, due to efficiency improvements, power generation is also expected to increase by 33 giga watt hours (GWh)/year and reduce ~27,000 tonnes of CO2 emissions per year.

Explaining its impact, he said that on a typical 10 square meter roof area, installation of a 2-star solar panel in place of a 1-star panel will result in approximately 12 percent additional power generation as compared to 1-star. This increase in solar panel efficiency can be 29% to 35% when compared to 4-star and 5-star panels.

# India To Emerge As Top Battery Manufacturing Hub





- **S.O.** 4669(E).—In exercise of the powers conferred by sub-section (1), clauses (v) and (vii) of sub-section (2) of section 3, sub-section (1), clauses (c) and (d) of sub-section (2) of section 6, section 8, clause (b) of sub-section (2) of section 25 of the Environment (Protection) Act, 1986 (29 of 1986), the Central Government hereby makes the following rules to amend the Battery Waste Management Rules, 2022, namely:-
- 1. (1) These rules shall be called the Battery Waste Management (Amendment) Rules, 2023.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Battery Waste Management Rules, 2022 (hereinafter referred to as the said rules), in rule 3, in sub-rule (1), —
- (a) for clause (c) the following clause shall be substituted, namely:—
  - "(c) 'Battery' means new or refurbished cell or Battery, including accumulator, which is any source of electrical energy generated by direct conversion of chemical energy and includes disposable primary or secondary battery;";
- (b) in clause (u), for sub-clause (iii), the following sub-clause shall be substituted, namely:—
  - "(iii) import of Battery or equipment containing Battery; or
  - (iv) manufacture or assembling of Battery or refurbished Battery including in equipment for sale to the Producer mentioned in sub-clause (ii) without its own brand name;".

- 3. In rule 4 of the said rules. —
- (a) for sub-rules (1) and (2), the following sub-rules shall be substituted, namely:—
  - "(1) Every Producer shall have the obligation of Extended Producer Responsibility for the Battery that they introduce in the market and the Battery which they put to self-use, to ensure the recycling or refurbishing obligations as per Schedule II;
  - (2) Every Producer shall have the obligation for environmentally sound management of preconsumer waste battery generated during manufacturing or assembling or import of a Battery or Battery pack and every Producer shall file the annual returns in Form 3 in respect of preconsumer waste battery generated in the preceding financial year.
  - (2A) Every Producer shall meet the collection and recycling and refurbishment targets as mentioned in Schedule II for Battery or Battery pack made available in the market including the Battery which they put for self-use.";
- (b) for sub-rules (4) and (5), the following sub-rules shall be substituted, namely:—
  - "(4) Every Producer shall obtain registration from the Central Pollution Control Board through online centralised portal in Form 1(A).
  - (5) The Central Pollution Control Board on registration of the Producer shall issue a certificate of registration in Form 1(B) to such Producer which shall be valid until it is cancelled or withdrawn.";
- (c) for sub-rule (6), the following sub-rule shall be substituted, namely:
  - "(6) Every Producer shall inform the Central Pollution Control Board of any changes to the information contained in the Extended Producer Responsibility registration.
  - (6A) In case the Producer stops its operations, the Producer shall have to discharge its Extended Producer Responsibility obligation in respect of Batteries already made available in the market till closure of operations, in accordance with provisions of these rules.";

- 4. In rule 8 of the said rules, for sub-rule (4), the following sub-rule shall be substituted, namely:
  - "(4) The total weight of waste Battery processed by entity involved in refurbishment of waste Battery, on quarterly basis, shall be made available on the portal developed by the Central Pollution Control Board for generation of Extended Producer Responsibility certificates."
- 5. In rule 9 of the said rules, —
- (a) for sub-rule (4), the following sub-rule shall be substituted, namely:—
  - "(4) The total weight of waste Battery processed by entity involved in recycling of waste Battery, on quarterly basis, shall be made available on the portal developed by the Central Pollution Control Board.":

- (f) for sub-rule (9) the following sub-rule shall be substituted, namely:
  - "(9) An Extended Producer Responsibility certificate in a category can only be used for offsetting, carry forward and sale for the same category of Battery.";

  - (16) The operation and regulation of electronic platform (s), so established under sub-rule 15 for trade of Extended Producer Responsibility certificates between obligated entities, shall be as per guidelines notified by the Central Government based on the recommendations of Central Pollution Control Board for the purpose.
  - (17) The Central Pollution Control Board shall fix the highest and lowest price for Extended Producer Responsibility certificate every six month or as required, keeping in view the cost for collection and environmentally sound management of waste Battery and the environmental compensation regime in force."

- (a) in sub-rule (3), after the word "application", the following words shall be inserted, namely:

  "and on the expiry of the said period of two weeks, the registration shall be deemed to be
  done, if not refused by the Central Pollution Control Board.";



#### Naraka Chaturdashi

Naraka Chaturdashi is associated with Diwali celebrations. Lord Krishna had killed Narakasura on the day of Naraka Chaturdashi, hence the victory of Lord Krishna is celebrated on this day.

It should be noted here that Diwali in South India is celebrated a day before it is celebrated in North India.

The celebration of Diwali in North India is based on the return of Lord Rama to Ayodhya from his exile. But in South India it is based on Lord Krishna killing the demon Naraka with the help of Satyabhama.

With the help of Brahma's boon, the

demon Naraka, son of Bhumi Devi and Vishnu, had become very powerful. The boon was that he could be killed only by his mother Bhoomi Devi. Due to such immense power, Naraka lost his self-control and became very arrogant. He started harassing people and gods and goddesses. He also forcibly snatched away the earrings from Devta's mother Adifi.

Ultimately, the task of destroying Naraka fell upon Lord Krishna. As always, Lord Krishna cleverly recruited his consorts Satyabhama and Bhoomi Devi to his side so that they could accompany him in the fight against Naraka and become his charioteer.

The fight between Naraka and Krishna shook the entire world. During the fight, an arrow shot by Naraka hits Krishna and the arrow renders Krishna unconscious. Satyabhama could not bear this and took Krishna's bow and arrow and killed the demon Naraka.

It is said that before dying Naraka realized his mistakes and requested his parents to have a festival celebrated by the people in his name. Therefore, after the day of Diwali, the household garbage etc. is taken out of the house, that is, this festival is also celebrated to throw out the hatred, jealousy, pride etc. within people. This festival will remind people what happens when they are egoistic and what happens after that egoism ends. Naraka Chaturdashi also indicates that good and evil spring from the same root.

the goddess of wealth, and marks the beginning of the new year, especially for the business community. They settle their accounts and open new books.

Every nationality in India has its own reasons for this Diwali celebration. But, the underlying theme is the victory of good over evil and spiritual enlightenment.

It was the day of Diwali when Shri Ram returned to Ayodhya after killing Ravana and was coronated. Ayodhya was immersed in darkness due to Ram being in exile for a long time. In his absence Ayodhya was in darkness and the forests were filled with light.

The return of Ram was considered by the people of Ayodhya as the return of divine coincidence and hence they welcomed Lord Ram by lighting lamps everywhere.

Not only this, apart from this, it is the day on which God in his Vamana avatar sent Emperor Bali to hell with his foot after getting the promise of three feet of land (measured by the Lord's feet) from Bali. Vamana (as an incarnation of Vishnu) gifted three feet of land to appease Bali's ego.

Diwali is a festival celebrated as a celebration of the suppression of ego. Man is immersed in the darkness of ignorance and has lost the power of discrimination between the permanent and the profane. When the darkness of ignorance caused by ego (egoconsciousness) is removed by the light of divine knowledge, the divine is experienced. Diwali is also the day on which Emperor Vikramaditya ascended the throne.

If the darkness of ignorance is to

be dispelled, man needs a vessel, oil, a wick and a matchstick which takes the form of an external lamp. When the light of the soul is divine then the light of knowledge appears and it dispels the darkness of ignorance.

The intrinsic significance of Diwali is to take man from darkness to light. Man always remains immersed in darkness. When he is engulfed in darkness, he should light a lamp which is shining in the temple of his mind. Wherever you go, take that lamp with you. Where there is light in the form of a lamp, you will automatically attain the right path.

# Shri Lakshmi ji resides here

Mahalakshmi, it is mandatory to keep many other things in mind along with worshipping. Here today we are telling you the special measures to please Mahalakshmi which were told by Lakshmi herself to Devraj Indra. Dialogues of Devraj Indra and Mahalakshmi are given in Shanti Parva of Mahabharata. In these dialogues it is told how Lakshmi does not reside in the houses of people who do wrong. Even today, poverty prevails in homes where these things are not taken care of.

According to the incident given in Mahabharata, once upon a time when Goddess Lakshmi had left the demons and came to reside at the place of Devrai Indra, then Indra had asked

Lakshmi that for what reasons had she left the demons? In response to this question, Lakshmi explained the reasons for the rise of the gods and the fall of the demons.

Lakshmi told that those who fast, leave their bed every day before sunrise, do not consume curd and sattu before sleeping at night, have darshan of ghee and sacred objects early in the morning, Time never sleeps, Lakshmi always resides in the homes of people who take care of all these things. In earlier times, all the demons also followed these rules, that is why I was residing at their place. Now all the demons have become unrighteous, that is why I have abandoned them.

Mahalakshmi told Indra that I

reside in the houses of men who are charitable, intelligent, devoted and truthful. I do not reside with those who do not perform such actions.

Lakshmi ji says that in earlier times I used to reside in the kingdom of demons, but now unrighteousness has started increasing there, that is why I have come to reside in the place of gods. Those who do not offer prayers to their ancestors or do charity or charity, I never reside in their place. In earlier times, demons used to do charity, study and yagya, but now they have indulged in sinful activities. Therefore, I cannot reside at their place. Mahalakshmi has said in Mahabharata that where fools are respected, they do not reside there. Lakshmi does not reside in those houses where women become mischievous i.e. of bad character, where women do not follow the rules of living and sitting properly, where women do not maintain cleanliness. Goddess Lakshmi told that she herself is Dhanalakshmi, Bhooti, Shri, Shraddha, Medha, Sannati,

Vijayiti, Sthitti, Dhriti, Siddhi, Samriddhi, Swaha, Swadha, Niyati and Smriti. They always reside in the country, city and homes of religious men. Lakshmi bestows her blessings only on those people who do not run away in battle and defeat their enemies with muscle power. Lakshmi is always happy with brave people. I do not live in houses where purity is not maintained while cooking, where ghee is touched with bare hands. Lakshmi ji said that I leave the house where the daughter-in-law rules over her in-laws and father-inlaw like servants, torments them and disrespects them. I shun those houses where the wife harasses her husband. does not obey her husband's orders, has immoral relations with men other than her husband. I do not shower blessings on those people who laugh at the losses of their well-wishers, hold grudges against them, and harm them by making friends. Such people always remain poor.



hen the seven colours of the spectrum come V V together, the effect is 'no colour'; when they stand apart, the seven colours can be separately identified. The betel nut is brown, betel leaf is green and the chunnam (slaked lime) is white, but when you chew these three together, your tongue becomes red. When the three blades of a ceiling fan revolve fast enough and no blade is separately noticeable, they give cool comfort. So too only when the different qualities of Sathwa, Rajas and Thamas are unrecognisably integrated, one can be happy. When the three gunas are equated in saadhana (spiritual practice), the result is peace. The lamp is the sathwa guna, the wick is the thamo guna and the oil is the rajo guna. When all the three are integrated, they give the light of wisdom, which illumines.
